Ansell National Safety Congress Race Helmet Contest

OFFICIAL RULES

1. **ELIGIBILITY:** NO PURCHASE NECESSARY TO ENTER OR CLAIM PRIZE. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING. The Ansell Race Helmet ("Promotion") is a trade promotion that begins on October 26, 2009 and ends on October 27, 2009.
